#### **Maio Biodiversity Foundation**

Maio Biodiversity Foundation (FMB - Fundação Maio Biodiversidade) was established in 2010 to protect biodiversity on the island of Maio, one of the remaining pristine islands in the Republic of Cabo Verde. Maio has sandy beaches where a large number of sea turtles nest; wetlands that support migratory and resident birds; and highly productive marine ecosystems, with shark nurseries, coral communities, and a large variety of fish species. The conservation of this rich biodiversity is essential to guarantee the social and economic wellbeing of the people of Maio, who depend mostly on fishing and agriculture for their income.

Since its establishment, FMB has rapidly grown to be one of the most successful conservation NGOs in West Africa. We have developed internationally recognised projects on marine protected areas, sea turtle conservation, bird protection and ecotourism, and initiatives that are replicated at a national level, such as our 'Guardians of the Sea' initiative in collaboration with local fishermen. FMB's mission is the sustainable development of Maio, based on biodiversity protection and the well-being of Maio's communities. As such FMB has strong links with local communities, and our projects are supported by local, national, and international organisations. # **The Opportunity**

To continue this dynamic development, FMB is looking for a Marine Programme Coordinator to join our team in Cabo Verde. We have ongoing projects on sharks, turtles, coastal and sea birds, biodiversity monitoring (with target groups such as reef fish and cetaceans) and marine protected area monitoring and management. The Marine Programme Manager will be expected to both coordinate the programme and get involved in fieldwork, including working with fishers, communities, and survey work, for which diving skills are necessary. The ideal candidate will bring enthusiasm and energy to strengthen and expand FMB's existing marine monitoring work, and to develop new projects. Tasks are varied and challenging so the individual must be adaptable and a good team player. The Marine Programme Coordinator will be supported by an excellent team of Cabo Verdean and international colleagues that have grown together over the last 12 years. Their work will also be supported by a strong network of national and international organisations, for example, our partner Fauna and Flora International (FFI). Fluency in Portuguese or Spanish is essential.

# General responsibilities

- Planning and implementation of conservation projects with a particular focus on marine projects, from inception to reporting
- Drafting and completion (often in English) of technical and financial reports on conservation projects
- Technical support to the FMB Protected Areas Coordinator
- Setting strategy and long-term planning for FMB's conservation portfolio, working together with the Director and other staff at FMB
- Recruitment and line management of the 'Marine team' (2-3 technicians)
- Developing budgets for a range of conservation projects from small to large
- Supporting the operations team in long-term financial planning for the organisation
- Financial management for conservation projects and grants e.g., keeping cashbooks, getting quotes, liaising with, and managing suppliers and contractors
- Representing FMB and promoting conservation to government and partners, maintaining a good relationship with all key stakeholders and funders
- Coordinating, leading and/or supervising monitoring and research projects by third parties, (e.g., universities, consultants, researchers, students)
- Ensuring a monitoring programme that measures the ecological and social impact of FMB's conservation activities
- Support field staff by carrying out fieldwork when necessary
- Create, maintain, and build trust with fishers and communities
- Create, manage, and maintain databases on biodiversity and other marine programme data
